Hemduth Rugbeer presents issues similar to Jyrki Pulkkinen's research, but Hemduth Rugbeer's focus on information and communication technology rather than Jyrki Pulkkinen's. This may be because Hemduth Rugbeer is a South African researcher. Hemduth Rugbeer is therefore less focused on the educational system, as Jyrki Pulkkinen, a Finnish researcher with more advanced equipment.

Hybrid Home School refers to a combination of education management between home school and school. The principle of Hybrid Home School is that the child must go to school for no more than 3 days in a week, and the remaining 4 days to study with parents at home or go on a field trip to various learning sources.

Schraass [11] said the heart of Hybrid Home School is Blended Learning and Blended Learning, Lecture-based Learning with Online-based Learning system. The advantage of Hybrid Home School is that parents can spend more time with their children. Because children will have to go to school for 3 days and there will be experts to teach supplementary courses that parents are not good at, so the unsolvable problems that fear that Home School children will not be able to socialize will be gone because they have attended school activities with Friends 3 days and now the online teaching materials are much more affordable.
